FIRE DEPARTMENT MONTHLY REPORT

June 2018

This month's activities resulted in Station 36 responding to **95** calls for service; **64** incidents were for emergency medical and **31** incidents were suppression-related. **28** of the medical calls were BLS while **30** were ALS and **7** didn't require medical care. Station 36 responded to **41** calls within our section of the Village of Inverness and **5** calls in the other side of Inverness. The District logged **12** calls within the Southeast Area and **13** incidents in all other contract areas for an overall total of **120** calls.

Calls of Interest:

June 4th - A36 responded into Hoffman Estates for a structure fire. A-36 arrived on scene, established command and investigated, finding an electrical outlet on exterior of home on fire. Fire was extinguished with an extinguisher by crew from Engine 23.

June 15th – E36/A36 responded to a kitchen fire at 172 Blair, Inverness. 2 cast iron pans were actively burning on the stove top upon arrival. E36 and A36 crews dismantled the drawers, range, and part of the vent checking for extension. Although hot on the TIC, no extension was found. Minor smoke and soot damage to the adjoining rooms of the home.

June 24th – E36/ A36 responded into Hoffman Estates on a structure fire. E36 engineer assisted with a positive water supply. E36 also assisted with entry while A36 deployed a 2.5" line to attack the fire.

June 24th – E36 responded to a reported fire at the Inverness Country Club. E36 located an overheated A/C compressor.
