## **FIRE DEPARTMENT MONTHLY REPORT**

### **June 2016**

This month's activities resulted in Station 36 responding to **77** calls for service; **54** incidents were for emergency medical and **22** incidents were suppression-related. Station 36 responded to **42** calls within our section of the Village of Inverness and **9** calls in the other side of Inverness. The District logged **13** calls within the Southeast Area and **19** incidents in all other contract areas for an overall total of **109** calls.
