FIRE DEPARTMENT MONTHLY REPORT

May 2018

This month's activities resulted in Station 36 responding to **77** calls for service; **42** incidents were for emergency medical and **35** incidents were suppression-related. **17** Of the medical calls were BLS while **19** were ALS and **6** didn't require medical care. Station 36 responded to **38** calls within our section of the Village of Inverness and **4** calls in the other side of Inverness. The District logged **18** calls within the Southeast Area and **12** incidents in all other contract areas for an overall total of **107** calls.

May 2nd- Tender 36 responded into Barrington Hills (BCFPD) on a Code 4. TND-36 provided (4) loads of water. Approximate total of water provided was 15000 gallons.

D/C Mohr responded on the subsequent MABAS alarm and assisted with water supply operations.

May 12th- Tender 36 responded into South Barrington (BCFPD). This incident came in as an activated fire alarm but was upgraded to a Code 4. TND-36 crews performed salvage and overhaul at the scene.

May 22nd- Ambulance 36 responded to a fire in Hoffman Estates, they were assigned salvage and overhaul
