FIRE DEPARTMENT MONTHLY REPORT

July 2018

This month's activities resulted in Station 36 responding to **92** calls for service; **56** incidents were for emergency medical and **36** incidents were suppression-related. **13** of the medical calls were BLS while **27** were ALS and **16** didn't require medical care. Station 36 responded to **45** calls within our section of the Village of Inverness and **5** calls in the other side of Inverness. The District logged **6** calls within the Southeast Area and **16** incidents in all other contract areas for an overall total of **104** calls.
