FIRE DEPARTMENT MONTHLY REPORT

July 2015

This month's activities resulted in Station 36 responding to **80** calls for service; **39** incidents were for emergency medical and **41** incidents were suppression-related. Station 36 responded to **30** calls within our section of the Village of Inverness and **5** calls in the other side of Inverness. The District logged **12** calls within the Southeast Area and **9** incidents in all other contract areas for an overall total of **101** calls.
